

RESOLUTION NO. 7739

**RESOLUTION DESIGNATING PUBLIC STREET SEGMENTS  
AND ROUTES OF ACCESS WHERE THE OPERATION GOLF  
CARTS IS PERMITTED PURSUANT TO CHAPTER 6.17 OF THE  
RENO MUNICIPAL CODE.**

**WHEREAS**, on July 11, 2012, the City Council adopted Bill No. 6804 and Ordinance No. 6243, which amended the Reno Municipal Code Title 6 "Vehicles and Traffic," by adding Chapter 6.17 "Golf Carts," to establish regulations for the operation of golf carts within city streets or city right-of-way, in accordance with Nevada Revised Statutes; and

**WHEREAS**, pursuant to Chapter 6.17 of the Reno Municipal Code, City Council desires to designate the routes of access for the operation of golf carts as described in Exhibit A attached hereto; and

**NOW, THEREFORE, BE IT RESOLVED** that the public street segments as set forth in the attached Exhibit A are hereby designated as the routes of access for the operation of golf carts as allowed pursuant to Chapter 6.17 of the Reno Municipal Code; and
